II BUSINESS ARISING

2.1 Airforce Magazine Proposal

No decision to report. It was proposed that the PR and Image Committee be tasked to develop a plan to ensure the steady PR & Image receipt of articles.

ITEM ACTION STATUS

2.2 Legal Defence Fund

A teleconference of the PC Chairs was held 3 Sep. All committees were represented except PE and Northern Area. A consensus was reached, whereby all Provincial Committees agreed with the \$1/cadet fee to establish a Legal Defence Fund, with committee assessments to be based on the June 2002 Effective Parade Strength. Future discussions shall occur at the 2003 SAM and 2004 AGM and regularly thereafter to address the need for continued or annual contributions as there can be no guarantee that lawsuits would not surface in the future. A committee shall be established; financial resources of the Provincial Committees are a major consideration.

Committee Chair L. Bourgeois noted most Provincial Committees required authority from their members. His committee was tasked with developing a draft plan to address and fund this issue. Indemnity from Dept. of Justice will be sought.

2.3 RCAOpsO Conference

The annual RCAOpsO Conference will be held in Comox, BC in October. Jack Henwood shall be asked to represent the ACL. A report shall follow.

Flight safety shall be reviewed: the summer and fall of 2003 had seven accidents: five in Central, one in Atlantic and one in Eastern Regions.

2.4 Legal Claim – Economical Insurance

In response to Economical Insurance's denial of coverage for the injuries suffered by a cadet in August 2000, the ACL insurer at that time, our lawyer has forwarded a letter advising of intent to potentially launch legal action should this decision not be reversed.

2.5 Mail Vote

The expectation was that the proposal would be voted on prior to the 2003 SAM.

2.6 Provincial Committee Funding Proposal

The Army Cadet League has requested a letter of support from the ACL to ensure continued buy-on with this proposal. L. Bourgeois stressed the importance of finding new sources of funding for this initiative rather than from the existing DCdts budget, although it was noted that expenditures exist that do not directly fund the cadet programme.

Discussions revealed that this proposal did not account for provincial or national volunteers when calculating the Leagues' contribution.

PROPOSAL: The Volunteer Contribution Report shall be forwarded to the Army Cadet League to ensure that all figures are accurate.

RECOMMENDATION: The Air Cadet League of Canada supports the funding proposal for Provincial Offices as developed by the Army Cadet League of Canada, except that any funding must come from "new money" and not the existing DCdts budget.

III New Business

3.1 Partnership - Report

- J.R. Goudie stated the three current priorities of this committee:
- a. responsibility matrix: he expressed disappointment that the joint focus groups in some regions do not include ACL involvement:
- b. impact statement: to be developed for each matrix item, assuming approved, to outline the effect on current regulations and orders. A plan shall be drafted on implementation;
- c. preparation of NCC presentation: the issue of liability is a major concern and the financial impact on the Leagues. A proposal to change the CIC transaction system shall also be included.

The need for Provincial Committees to provide information to members at their AGMs was noted, particularly regarding the status of screening CO's volunteers. L. Bourgeois consented to prepare a brief.

3.2 National Fund Raising Campaign

J. Mignault reviewed the results of the national campaign to date and outlined plans to place an insert in an upcoming COPA mailing. Special thanks were extended to Ron Button for his work with securing two donations totalling \$70K to be used to fund Air Cadet awards.

3.3 Insurance

Insurance policies were renewed 31 Aug with an average 23% increase in premiums; these were due to market forces beyond ACL control.

Discussion ensued on the difficulty in getting information from DND regarding claims against the ACL with suggestions that DND assume cadet liability. J.R. Goudie noted that there is no provision for the sharing of information.

3.4 Quarter I Financial Results

The (deficit)/surplus for 2002 was incorrectly stated on the **Info Closed** report; it should read \$28,630 Surplus.

3.5 Semi-Annual Meeting
