## 2.1 Signing of MOA

The MOA has been signed by the ACLC. DCdts have had it reviewed by the lawyers at JAG, it will be signed shortly. Insurance certificates to be issued to the Air Ops Officers.

# 2.2 Joint Study Committee - NFC

R. Ilko has sent a letter to DCdts confirming the members and mandate for the ACLC team members. J. Elias of DCdts will respond and is attempting to set-up the 1<sup>st</sup> meeting before the end of March 2001. Major issue for ACLC, R. Ilko expects significant progress before AGM. J. Mignault to follow up with NF Provincial. Committee to ensure they are happy with allocation of more funding by Atlantic RC Air Ops O, for power familiarization flights.

# 2.3 Future Semi-Annual Meetings

Contract with RCAF Officers Mess has been signed. Dates are Nov. 15-17, 2001. Contract also signed with Lord Elgin Hotel, \$102/night and no charges for meeting rooms. Hotel 2 blocks form RCAF Officers Mess. BOG, Provincial Chairs and Advisory Board/Nominating Committee are the only Committees expected to attend. National Flying Committee Members expected to attend earlier at same time as Air Ops Officer Meeting. Note no room charges also at RCAF Officers Mess.

### 2.4 Directors & Officers Liability Insurance

J. Mignault explained that correspondence received by Insurance Broker indicates that Insurer Encon, insures only national and provincial members. Insurer uncomfortable with autonomy of Sponsoring Committees and the lack of control by National and Provincial League offices. They feel the exposure relative to Sponsoring Committees is much higher than their original understanding for the premiums collected (\$13.8K last year). Broker instructed to pursue coverage for all League members and/or for a new Insurance Company. Need to assess the implications of incorporating Squadron Sponsoring Committees and Provincial Committees. Legal opinion will be sought for best venue to re-organize the League structure for the future.
