## 2.3. Bouchard-Canon Lawsuit – S. Matresky

S. Matresky indicated that a mediation session is set to take place in the next month or two. This is where the insurance company, the League and or DND can offer a settlement or decide to go to trial. The lawyer has recommended that if the insurance company does not offer a settlement the ACL should proceed to trial as the insurance company continues to pay for the defense. The risk involved with a trial is that we could be found liable and be forced to pay in the end. The League does not have 'no-fault' insurance and the underwriters continue to say that they will not payout. The underwriters are being counter sued by DND as they feel that they should in fact pay. S. Matresky is looking for some direction/instruction from the Board on how to proceed at the mediation (offer a settlement on behalf of the ACL? proceed to trial?).
