3.1	STATUS OF THE LEAGUES REGISTERED PENSION PLAN FOR FORMER EMPLOYEES J. Mignault and the Executive Committee are monitoring the investments in the League's Defined Benefits pension Plan (now frozen) for one existing pensioner, one former employee and one current serving employee. The League is looking to purchase an annuity as soon as possible with a view of providing closure to the plan (i.e. pending favourable market conditions). 3.3	UPDATE ON REIMBURSEMENT OF SCREENING COSTS Four Provinces responded before the deadline, NS, QC, MB and SK. Along with the amounts claimed by National, J. Mignault claimed an excess of \$14,000 for reimbursement. DCdts staff looked at the request and allowed 50% reimbursement – thus an invoice for \$7,092.92 was submitted on Tuesday March 13, 2007.
