ITEM ACTION STATUS

Gen P. Manson, Chairperson for the "Passing the Torch" campaign for the Canadian War Museum, provided background on their fund raising efforts for a new museum and requested consideration for assistance from the squadrons. Numerous military and service groups have assisted and the CWM would like Air Cadet involvement in two areas:

- 1. financial contributions (local level initiatives)
- link the Air Cadet Movement with the new museum by bringing cadets in to ceremonies at the CWM to show that our heritage is not forgotten and the symbolism of youth working with veterans.

The CWM would respond by naming a room in the new museum in honour of cadets. Gen Manson suggested an average of \$1 per cadet to reach this goal. It would be at the discretion of the local squadrons how to raise this amount at a one-time event - L. Bourgeois suggested that cadets could be twinned with Legion branches currently doing fundraising.
